- The attached documentation responding to the review criteria below shall be no more than six pages in length.

- Nominees must demonstrate their strong support and dedication to aviation in Kentucky and have a minimum of five years working experience in the aviation industry.
- Nominations will be reviewed and selected by the Board of Directors of the Kentucky Aviation Association.

### REVIEW CRITERIA

- How does nominee embody a broad depth of knowledge & understanding of all aspects of aviation;
- How has nominee demonstrated a proven record of contributions through maintaining or overseeing aviation facilities and airport improvement projects;
- How has nominee acted as a mentor to aviation-interested individuals in their community;
- How has nominee promoted his/her airport throughout their community; and
- How involved is nominee with respect to the local, state and federal aviation community overall?
